10	Section 1. Subsection (18) of section 318.18, Florida
11	Statutes, is amended to read:
12	318.18 Amount of penalties.— The penalties required
13	for a noncriminal disposition pursuant to s. 318.14 or a
14	criminal offense listed in s. 318.17 are as follows:
15	(18) In addition to any penalties imposed, a surcharge
16	of \$3 must be paid for all criminal offenses listed in s.
17	318.17 and for all noncriminal moving traffic violations
18	under chapter 316. Revenue from the surcharge shall be
19	remitted to the Department of Revenue and deposited
20	quarterly into the State Agency Law Enforcement Radio
21	System Trust Fund of the Department of Management Services
22	for the state agency law enforcement radio system, as
23	described in s. 282.709, and to provide technical
24	assistance to state agencies and local law enforcement
25	agencies with their statewide systems of regional law
26	enforcement communications, as described in s. 282.7101.

This subsection expires July 1, 2031 2026. The Department 27 28 of Management Services may retain funds sufficient to 29 recover the costs and expenses incurred for managing, 30 administering, and overseeing the Statewide Law Enforcement 31 Radio System, and providing technical assistance to state agencies and local law enforcement agencies with their 32 33 statewide systems of regional law enforcement 34 communications. The Department of Management Services 35 working in conjunction with the Joint Task Force on State 36 Agency Law Enforcement Communications shall determine and 37 direct the purposes for which these funds are used to 38 enhance and improve the radio system. 39 Section 2. Subsection (17) of section 318.21, Florida 40 Statutes, is amended to read: 41 318.21 Disposition of civil penalties by county 42 courts.—All civil penalties received by a county court 43 pursuant to the provisions of this chapter shall be 44 distributed and paid monthly as follows: 45 (17) Notwithstanding subsections (1) and (2), the proceeds from the surcharge imposed under s. 318.18(17) 46 47 shall be distributed as provided in that subsection. This subsection expires July 1, 2031 2026. 48 49 Section 3. This act shall take effect July 1, 2026.
